INTRODUCTION

- 1. Since at least 2014, the Marin County Sheriff's Office (the "Sheriff's Office" or the "Sheriff") has shared and transferred the sensitive location information of its residents and the people who travel through its boundaries with federal, state, and local agencies across the country, including federal immigration agencies. The Sheriff collects this information using a system of Automated License Plate Reader ("ALPR") cameras, a surveillance technology that automatically records the locations of cars and any visible drivers using cameras mounted on patrol cars, light posts, or other infrastructure.
- 2. ALPR cameras can automatically scan and record the time-stamped locations of thousands of drivers per day regardless of whether those drivers have violated any law.

 Government agents use this location information to track people's movements, habits, and associations over time, including where a person lives, worships, and receives medical care. When counties and municipalities like Marin County share and transfer this information to federal immigration agencies, it is used to track, detain, and deport immigrants.
- 3. The Sheriff's practice of sharing and transferring this personal information violates state law in two ways. First, it violates a law known as Senate Bill 34 ("S.B. 34"), Cal. Civ. Code §§ 1798.90.5 *et seq.*, which protects the privacy of all motorists by limiting how government agencies may share their ALPR information. Second, it violates the California Values Act, Cal. Gov't Code §§ 7284 *et seq.*, which limits the use of state and local resources to assist federal immigration enforcement.
- 4. The Sheriff's sharing and transferring of sensitive personal information with federal immigration agencies is consistent with the Sheriff's long and troubling history of targeting immigrant communities, including the Sheriff's collaboration with Immigration and Customs Enforcement ("ICE") to transfer immigrant community members to ICE custody.
- 5. Plaintiffs Cesar Lagleva, Jr., Lisa Bennett, and Tara Evans are long-time members of the Marin County community, as well as Marin County homeowners, business owners, and taxpayers. They are committed advocates for immigrant justice, racial justice and equity, and the human and civil rights of Marin County residents. They drive on a daily basis throughout Marin

County to work, drop off their children at school, meet friends and loved ones, volunteer, and participate in myriad forms of civic and political life to advance their values.

- 6. The Sheriff collects massive amounts of location information of Plaintiffs and other drivers who have no choice but to travel by car through Marin County on a regular basis. The Sheriff then shares and transfers that sensitive personal information across the country to agencies not subject to the important privacy protections imposed by the California legislature. The Sheriff misappropriates and wastes taxpayer funds by spending those monies to share and transfer ALPR information in violation of S.B. 34 and the California Values Act.
- 7. Plaintiffs seek to restrain and prevent the illegal expenditure of county funds and to compel Defendants to comply with state law by ending the sharing and transferring of ALPR information with out-of-state and federal entities. Plaintiffs also seek to stop the Sheriff from sharing and transferring ALPR information to agencies the Sheriff knows or should know provide this information to out-of-state or federal entities.
 - 8. Plaintiffs seek declaratory, injunctive, and mandamus relief to end this harm.

JURISDICTION AND VENUE

- 9. This court has jurisdiction under Cal. Code Civ. Proc. §§ 410.10, 525, 526, 526a, 1060, and 1085.
- 10. Venue is proper in the Superior Court of Marin County under Cal. Code Civ. Proc. §§ 393, 394, and 395 because Defendant Robert Doyle is a public officer being sued in his official capacity for acts he performed as part of his public duties that have caused, and will cause, legal injuries and deprivation of rights to persons in Marin County; this action is a proceeding against Marin County; and all material actions and omissions occurred in Marin County.

PARTIES¹

I. Plaintiffs

11. Plaintiff Cesar Lagleva, Jr. is a long-time homeowner and taxpayer in Marin County. An immigrant from the Philippines, Mr. Lagleva moved to the Canal neighborhood in San

Rafael, Marin County as a child. He attended and graduated from public schools in San Rafael. After receiving his social-work degree, Mr. Lagleva entered a career in public service. He worked for over twenty years in the Marin County Health and Human Services Department, including many years with the Department's Behavioral Health and Recovery Services Division as a Mental Health Practitioner. In that role, he worked with culturally and ethnically diverse juvenile-justice-involved youth and their families. Mr. Lagleva has served as a commissioner on the Marin County Human Rights Commission. He works as an educator and a consultant for immigrant-focused programs. Mr. Lagleva has also engaged in a wide range of advocacy on behalf of the immigrant communities in Marin County, including with non-profit organizations and grassroots groups. He has received numerous awards recognizing his contributions to advancing the human and civil rights of Marin communities. Mr. Lagleva has an interest in ensuring that drivers and immigrants in Marin County are not harmed by Defendants' unlawful sharing and transferring of ALPR information. Mr. Lagleva has been assessed and paid taxes that fund Defendants within the last year, including sales and use taxes and property taxes.

- 12. Plaintiff Lisa Bennett is a homeowner in Marin County. She is an active member of the civic landscape of Marin County. She has spoken at public forums held by the Marin County Board of Supervisors to urge the County and the Sheriff to end practices that harm immigrants in the community. Ms. Bennett has an interest in ensuring that drivers and immigrants in Marin County are not harmed by Defendants' unlawful sharing and transferring of ALPR information. Ms. Bennett has been assessed and paid taxes that fund Defendants within the last year, including sales and use taxes and property taxes.
- 13. Plaintiff Tara Evans is a resident of Marin County. She attended and graduated from public schools in Marin County and attended the College of Marin. She has served as the Chair of the Stinson Beach Village Association. She is an active participant in numerous civic activities, including advocacy to achieve equitable outcomes in Marin public schools and for West Marin's significant Latinx population. Ms. Evans has an interest in ensuring that drivers and immigrants in Marin County are not harmed by Defendants' unlawful sharing and transferring of

ALPR information. Ms. Evans has been assessed and paid taxes that fund Defendants within the last year, including sales and use taxes and utility taxes.

II. **Defendants**

- 14. Defendant County of Marin is a political subdivision of the State of California. The County of Marin funds and controls the operations of the Sheriff's Office, including the acquisition and use of an ALPR system.
- 15. Defendant Robert T. Doyle is the Marin County Sheriff and the head of the Sheriff's Office, which is the County's principal law enforcement agency. Sheriff Doyle, the Sheriff's Office, and their agents control the acquisition, funding, and use of the ALPR system, including the establishment and implementation of policies and practices relating to the ALPR system and the sharing and transferring of ALPR information with agencies that are not "public agencies" as defined by S.B. 34, including out-of-state and federal agencies. Sheriff Doyle is sued in his official capacity.

STATEMENT OF FACTS

- I. Automated License Plate Readers Are An Invasive Mass Surveillance Technology.
 - 16. Automated license plate readers are a mass-surveillance technology.
- 17. ALPR cameras automatically capture color images of license plates of drivers that pass within their field of view, even though the overwhelming majority of drivers have not violated any law. Fixed cameras are mounted on stationary objects or infrastructure, such as light poles or overpasses, while mobile cameras are mounted on moving objects, such as patrol cars.
- 18. Software extracts the license plate numbers from the images and stores the images, license plate numbers, and precise dates, times, and Global Positioning System ("GPS") coordinates of the image captures in a searchable database. Although the primary focus of each image is the license plate, the image may also show part of the vehicle itself, including individuals within the vehicle, depending on the camera's position. The photograph, plate number, GPS location coordinates, and date and time information are collectively referred to herein as "ALPR information."

- 19. An ALPR system consists of the cameras, the software that reads and converts images of license plates into data, and the searchable database that stores the data.
- 20. Government agents can easily search the databases storing ALPR information. They may search for a full license plate number to locate a specific vehicle, search for a partial license plate number to locate a group of vehicles, or search for all vehicles recorded in geographic area at specific times. In addition, after the ALPR system identifies a license plate number in an image, it compares the plate number to stored lists of license plate numbers from vehicles of interest, called "hot lists," and notifies the agency that listed the vehicle of a match, called a "hit."
- 21. A single ALPR camera can capture the locations of thousands of drivers in a short time, all without any human involvement. For example, the Sacramento County Sheriff once captured 1.7 million plates in one week, according to a 2020 California State Auditor report.
- 22. ALPR systems radically decrease the personnel and equipment costs necessary for government authorities to effortlessly surveil drivers *en masse*, removing a traditional check on government power by permitting the dragnet and continuous surveillance of entire communities in a manner that did not exist before the invention of modern surveillance systems. By tracking and recording where people are across time, ALPR information can reveal a person's private habits, movements, and associations.
- 23. A person who regularly drives through an area subject to ALPR surveillance can have their location information captured multiple times per day. This information can provide an intimate window into a person's life as they travel from home to work, drop off their children at school, or park at a house of worship, a doctor's office, or a protest.
- 24. Location information revealing people's physical movements, even in public spaces, enjoy constitutional protection under the Fourth Amendment. That protection exists because the recording of individual movements over time reveals sensitive information about a person's private life. The U.S. Supreme Court has held that "[a] person does not surrender all [privacy] protections by venturing into the public sphere," recognizing that modern location tracking allows the Government to "travel back in time to retrace a person's whereabouts,"

- 31. Like many law enforcement agencies across the country, the Sheriff's Office uses a software and database called LEARN, created and operated by a company called Vigilant Solutions, in order to share and transfer ALPR information, including with federal and out-of-state agencies.

 32. Federal immigration agencies use the ALPR information shared with them by the
- 32. Federal immigration agencies use the ALPR information shared with them by the Sheriff's Office and other law enforcement agencies to locate, detain, and deport immigrants.
- 33. Since at least 2019, ICE has received ALPR information shared and transferred by local agencies via the LEARN nationwide database. Local law enforcement agencies can share with ICE, through the LEARN nationwide database, the location of hundreds of millions of scans of vehicle license plates that their ALPR cameras have captured.
- 34. ICE has conducted thousands of searches of the ALPR information shared with and transferred to it via the LEARN nationwide database. In a several-month period in 2018, ICE performed over 30,000 searches per month of the ALPR information shared via the database.⁴ Through its searches, ICE has tracked individuals to arrest them for alleged violations of immigration law, such as overstaying visas or working without authorization. ICE's records indicate that ICE officers have searched the LEARN database to conduct surveillance of family members—with no apparent protections to ensure that U.S. citizens are not ensnared—in order to arrest and deport immigrants. ICE has also requested and received ALPR information by email from local law enforcement agencies, circumventing any limitations contained in the LEARN nationwide database on the sharing and transferring of ALPR information.⁵
- 35. CBP has also used ALPR information shared and transferred to it by local agencies and private actors through the LEARN nationwide database. 6 CBP's use of this surveillance

technology is deeply troubling, given CBP's long and well-documented history of violence against immigrants, profiling and expulsion of people seeking humanitarian relief, and surveillance and retaliation against immigration attorneys and activists. Further, CBP's overreach to engage in domestic surveillance and policing—outside the bounds of its stated mission to safeguard U.S. borders—is well-documented.⁸

36. Considering such abuses by ICE and CBP, the Sheriff's rampant sharing of ALPR information with these agencies (and many other non-California agencies) harms the well-being and safety of local community members, needlessly subjecting them to law enforcement scrutiny and abuse in violation of state law.

Two California Statutes Limit the Sharing and Transferring of ALPR Information.

37. S.B. 34 addresses serious harms caused by this mass surveillance system. It also exemplifies how the California legislature can exercise its authority over in-state law enforcement agencies to impose critical safeguards and limitations. The law imposes clear requirements upon public agencies using and operating ALPR systems to prevent the mishandling and abuse of ALPR information, secure the right of the public to conduct oversight of ALPR system use, and ensure that access to ALPR information is justified, tracked, audited, and limited. Consistent with its focus on maintaining security, limited access, and privacy, S.B. 34 prohibits the sharing and

transferring of ALPR information with any agencies other than in-state agencies. S.B. 34 also requires California law enforcement agencies using ALPR systems to adopt usage and privacy policies, create reasonable security safeguards, and implement a system for auditing and limiting access to ALPR information.

38. The California Values Act, S.B. 54, recognizes the danger to the public and its safety when local law enforcement agencies entangle themselves with federal immigration authorities. To protect the safety, well-being, and constitutional rights of the people of California, the Legislature prohibited local law enforcement agencies from using personnel or funds for immigration enforcement purposes, including the sharing of personal information. This includes ALPR information.

III. The Sheriff Collects ALPR information on Thousands of Marin County Drivers.

- 39. Marin County and the Sheriff's Office first purchased ALPR technology in 2010.
- 40. The Sheriff currently operates an ALPR system consisting of ALPR cameras and LEARN software and database purchased and licensed from Vigilant Solutions.
- 41. The Sheriff currently operates twelve ALPR cameras. Eight of these cameras are assigned to its patrol division and four cameras are assigned to the auto theft division.
- 42. Using these ALPR cameras, the Sheriff collects vast quantities of information about Marin County residents and people who travel through its boundaries.
- 43. In 2018, the Sheriff used the ALPR system to record 678,936 scans of driver license plates and location information
- 44. In 2019, the Sheriff used the ALPR system to record 868,218 scans of driver license plates and location information.
- 45. In 2020, the Sheriff used the ALPR system to record 821,244 scans of driver license plates and location information.
- 46. Despite the hundreds of thousands of pieces of location information collected, only a sliver of the license plates captured by the Sheriff are "hits," or plates that are of interest.
- 47. In 2018, there were only 193 hits for 678,936 scans, meaning the ALPR system detected a match for only 0.02% of scans conducted that year.

- 48. In 2019, there were only 364 hits for 868,218 scans, meaning the ALPR system detected a match for only 0.04% of scans conducted that year.
- 49. In 2020, there were only 216 hits for 821,244 scans, meaning the ALPR system detected a match for only 0.02% of scans conducted that year.

IV. Marin County and the Sheriff Expend Taxpayer Funds To Share and Transfer ALPR Information with Out-of-State and Federal Agencies.

- 50. For many years, the Sheriff and his agents have shared and transferred ALPR information that they collect through the ALPR system with out-of-state and federal government agencies, including ICE and CBP.
- 51. The Sheriff and his agents use a software and database called LEARN to store, search, and share and transfer ALPR information with those outside agencies. LEARN provides a user interface to search license plates and the option to share ALPR information and "hot lists" with other agencies through the database.
- 52. The Sheriff stores ALPR information on the LEARN database, which is a cloud service, and shares ALPR information with other agencies that are users of LEARN.
- 53. Using the LEARN software, the Sheriff and his agents select and designate out-of-state and federal agencies as "sharing partners."
- 54. The Sheriff and his agents share and transfer ALPR information to the agencies they select as "sharing partners" by allowing the "sharing partners" to search for a license plate number among the ALPR information collected by the Sheriff. If that license plate number has been captured by the Sheriff's ALPR system, the Sheriff transfers, through LEARN and the ALPR system, the ALPR information associated with that matched license plate to the sharing partner agency. The Sheriff transfers not only a photograph of the license plate and surrounding area, but also the date, time, and location coordinates.
- 55. In addition to the method of sharing and transferring described above, the Sheriff shares and transfers ALPR information to other agencies by allowing those agencies to compare their own bulk lists of vehicle license plates of interest, known as "hot lists," against the ALPR information collected by the Sheriff.

- 56. If the Sheriff's ALPR cameras scan and capture a license plate that is on the "hot list" of one of these other agencies, the Sheriff's ALPR system transfers the ALPR information associated with that hit to the other agency.
- 57. The Sheriff can generate a "sharing report" from the ALPR system and LEARN software.
- 58. The "sharing report" is a list of the "sharing partner" agencies, including out-of-state and federal agencies, with whom the Sheriff shares and transfers ALPR information. The "sharing report" also lists the agencies whose "hot lists" the Sheriff and his agents have selected to run against the ALPR information collected by the Sheriff.
- 59. The Sheriff has consistently shared and transferred ALPR information with federal immigration agencies.
- 60. In 2014, an administrator for the Sheriff's ALPR system shared ALPR information collected by the system with three ICE sub-components, according to a 2020 report by the California State Auditor. That same report noted that the Sheriff was sharing and transferring ALPR information to the San Diego Sector of the U.S. Border Patrol (a sub-component of CBP) when the California State Auditor began its audit.
- 61. In 2021, a "sharing report" produced by the Sheriff lists 424 out-of-state agencies and 18 federal agencies, including two sub-components of CBP and ICE.⁹
- 62. As reflected in the "sharing report," the Sheriff shares and transfers ALPR information with at least 18 federal agencies. Two of these agencies support the federal government's immigration enforcement apparatus: CBP's National Targeting Center, and ICE's Homeland Security Investigations Bulk Cash Smuggling Center. The other federal agencies include the Federal Bureau of Investigation, the Forest Service, the Drug Enforcement Agency, and the Postal Inspection Service.
- 63. As reflected in the "sharing report," the Sheriff also shares and transfers ALPR information with at least 424 out-of-state agencies. This includes law enforcement agencies

designating out-of-state and federal agencies as "sharing partners"; and sharing and transferring Absent an order from this Court, the County and the Sheriff will continue to expend

- taxpayer funds, personnel time, and resources on this ALPR system, including on the sharing and transfer of ALPR information with out-of-state and federal agencies.
- Plaintiffs tried to resolve this matter by sending a letter to Sheriff Doyle. But Sheriff Doyle has not responded to Plaintiffs' demand that he cease the unlawful conduct

CAUSES OF ACTION

First Cause of Action Violation of Cal. Civ. Code §§ 1798.90.5 et seq. (All Plaintiffs Against All Defendants)

- The County and Sheriff violate S.B. 34 by sharing and transferring ALPR information to agencies that they know or should know share or transfer ALPR information to entities that are not "public agencies" as defined by S.B. 34, including to out-of-state and federal

Second Cause of Action Violation of Cal. Gov't Code §§ 7284 et seq. (All Plaintiffs Against All Defendants)

Plaintiffs re-allege and incorporate by reference each of the allegations above as if fully set forth herein.

PRAYER FOR RELIEF

- 84. Plaintiffs respectfully request this Court grant the following relief:
- a. A declaration that Defendants' sharing and transferring of ALPR information to entities that are not "public agencies" as defined by S.B. 34, including to out-of-state and federal agencies, violates S.B. 34;
- b. A declaration that Defendants' sharing and transferring of ALPR information to federal immigration agencies violates the California Values Act;
- c. A writ of mandate and injunction prohibiting Defendants from sharing or transferring ALPR information to entities that are not "public agencies" as defined by S.B. 34, including to out-of-state and federal agencies; from sharing or transferring ALPR information to entities that Defendants know or should know share or transfer ALPR information to entities that are not "public agencies" as defined by S.B. 34, including to out-of-state or federal agencies; or expending funds, resources, or employee time to do so, in compliance with S.B. 34;
- d. A writ of mandate and injunction prohibiting Defendants from sharing or transferring ALPR information to federal immigration agencies, or expending funds, resources, or employee time to do so, in compliance with the California Values Act;
- e. That all of these injunctive and mandamus orders bind Defendants' agents and those working in concert with them;
- f. Reasonable attorneys' fees and costs pursuant to Cal. Code Civ. Proc.§§ 1021, 1021.5, and any other applicable law; and
- g. All other relief the Court deems just and proper.
